NOTE ON THE PROCESS OF DUE DILIGENCE

Following details summarize our process of Due Diligence with respect to the proposed Initial Public Offer of OM GALAXY LIMITED (“Issuer”) on SME PLATFORM OF BSE LIMITED:

We have carried out due diligence on the Company for the purposes of complying with the requirements of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the “SEBI ICDR Regulations”), and other applicable laws, to the extent customary for initial public offerings of this nature in India, along with other professionals and experts engaged in connection with this Issue. All capitalized terms used herein and not specifically defined shall have the meanings ascribed to them in the Red Herring Prospectus dated September 04, 2026 (the “RHP”).

The due diligence process, undertaken by us and the legal counsel (as defined below), commenced with interactions with the senior management of the Company to gain an understanding of the business of the Company, the key risks involved, the background of the Promoters, and an overview of the financials, among others. In this regard, we provided the Company with a due diligence questionnaire and information requisition list prepared in consultation with the legal counsel. In response, the Company provided clarifications and explanations, along with supporting documents for our review. To facilitate such review, an online dataroom was set up, where copies of relevant documents were made available for diligence.

In conducting the due diligence, we were assisted by the legal counsel and the auditor. M/s. Shetty Naik & Associates, Statutory and Peer Review Auditor, and Khaitan & Khaitan, appointed as the legal counsel to the Issue, assisted the BRLM in carrying out the due diligence, drafting the RHP in compliance with the SEBI ICDR Regulations, and advising the BRLM and the Company on legal matters relating to the Issue. The auditors verified and provided certifications with respect to certain information, including, but not limited to, the Company’s key performance indicators and other financial and operational information disclosed in the RHP.

Further, M/s. D N Vora and Associates, independent practicing company secretaries, conducted and presented the search report vide certificate dated March 30, 2026 based on which following has been observed–

1. Non-availability of Challans for Statutory Filings

It is observed that, with respect to filings made by the Company from the date of its incorporation up to the financial year 2021–2022, the corresponding challans evidencing payment of statutory filing fees are not available in the records of the Company for verification.

2. Non-traceability of Form MGT-14 SRN

It is observed that Form PAS-3 filed in respect of the allotment dated 27th February, 2015 contains the SRN of Form MGT-14; however, the said SRN and Form MGT-14 is not traceable on the MCA portal and in the records of the company.

3. Inaccessibility of Attachments in Form AOC-4

It is observed that although Form AOC-4 is available in the records of the Company, the

4. Non-traceability of Share Transfer Deeds

- (a) The share transfer deed in respect of transfer of shares from **Mr. Sathyapalan Ayadathil Poyil** to **Ms. Meena O. Baddhan** dated 25th November, 2011 is not traceable in the records of the Company.
- (b) The share transfer deed in respect of transfer of shares from **Mr. Edavan Pulliyacheriyath Jyothish** to **Ms. Meena O. Baddhan** dated 25th March, 2014 is not traceable in the records of the Company.

Additionally, a certificate dated August 14, 2026, issued by Gauri Associates, Independent Chartered Engineer, in relation to the Company's Proposed New Manufacturing Unit, has also been obtained.

Business and Commercial Diligence

The due diligence process in relation to general business and commercial matters included:

- i. Organizing and attending the kickoff meeting, discussions to understand the business of the Company and other related matters. The discussion was attended by the senior management of the Company along with representatives of the Promoters, the Legal Counsel and representatives of BRLM. A broad overview of the business of the Company, industry in which it operates, regulatory framework with respect to the business, the corporate structure, the capital structure, and financial statements, its shareholding pattern and details of the promoters of the Company was presented to us and the Legal Counsel followed by interactive discussions;
- ii. Regularly interacting with the senior management of the Company as well as the senior personnel from the Legal, secretarial and finance departments, for the purpose of understanding the business, the risks involved and the financial overview of the Company, amongst other matters. These interactions included (i) due diligence related calls, virtual drafting sessions and conference calls to discuss the disclosures in the RHP, (ii) due diligence calls with the Auditor; (iii) seeking appropriate clarifications from the Company for key financial, operational data and other information; (iv) bring down due diligence calls to receive updated information from the Company before filing the RHP and (v) seeking appropriate certifications from the Company and the Auditor for other financial, operational data, amongst others.
- iii. Undertook physical site visits as part of our due diligence exercise which included visits to the Registered Office and subsidiaries. We interacted with the Company's senior management and employees at the Registered Office and subsidiaries. The site visits were carried out for our due diligence exercise to understand the Company's day-to-day operations and key business processes;
- iv. Requesting the Company to make available the due diligence documents in a virtual dataroom and reviewing those documents along with the Legal Counsel, based on the requirements under the SEBI ICDR Regulations and other applicable laws, as is customary in such transactions;
- v. Obtaining and relying on certificates and formal representations and undertakings from the

- (iii) pending litigation related to direct and indirect taxes, disclosed in a consolidated manner, giving the total number of claims and the total amount involved; and
- (iv) the pending litigation as determined to be material, in each case involving the Company, Promoters and Directors as per the policy of materiality adopted by the Board by a resolution dated February 17, 2026 ("**Materiality Policy**").
